DID YOU KNOW?

Here is additional information that you may find helpful and some suggestions for lower water usage that can save you money:

*Nearly twice the amount of water is used during the summer months as in winter months, with lawn watering the biggest reason for the increase. More water is lost by evaporation during the hot parts of the day so water your lawn in the early morning or late evening.

*Purchasing a low flow showerhead is a wise investment. Most only use less than 2 gallons per minute.

*Periodically check all hose connections, valves and pipes for leaks. Even a small leak can waste hundreds of gallons of water in a single day.

*The hardness of your water averages 11.9 grains per gallon.

*The District uses a chloramine solution for disinfection purposes.

*If you wish to do any plumbing work yourself, you must take out a plumbing permit with the District beforehand. This includes the installation of irrigation systems and pools. If you wish to hire someone else, they must be licensed in their particular field. Call the District office if you have questions concerning permitting matters.
